Key messages

SPA reported a 3Q22 net loss of Bt15mn (+81% YoY, +49% QoQ), in line with our expectation. We expect earnings to see continued improvement in 4Q22F and should turnaround in 1Q23F. With the positives partly priced-in, we re-iterate a rating of Neutral with a target price of Bt11.30.

3Q22 earnings review: In line with our expectation

Event

3Q22 earnings review.

Impact

Net loss narrowed to Bt15mn (+81% YoY, +49% QoQ)

SPA reported a 3Q22 net loss of Bt15mn (+81% YoY, +49% QoQ), in line with our expectation. The strong improvements both YoY and QoQ were backed by improving confidence over the COVID-19 situation, the recovery in tourist arrivals, and more branches re-opening. Note that around 96% of the company's spa branches were operating at the end of 3Q22, up from 90% in 2Q22. The 9M22 net loss came in at Bt102mn (+57% YoY).

Spa revenue was Bt180mn (substantial increase YoY, +56% QoQ). The improvement both YoY and QoQ was backed by increasing customer traffic (SSSG soared 1,100% in 3Q22). In terms of profitability, EBIT margin hit a multi-quarter high at -1% (up substantially YoY, +12.7ppts QoQ).

4Q22F earnings outlook to remain positive

We expect net losses in 4Q22F to continue to narrow both YoY and QoQ, while we expect earnings to turnaround in 1Q23F amid more customer traffic as well as continued growth for international tourist arrivals.

Valuation & action

Looking ahead, earnings momentum should be promising through 2023F and SPA should be a prime beneficiary from the Chinese tourist recovery theme. However, with the positives partly priced-in, we re-iterate a rating of Neutral and target price of Bt11.30, based on 54x 2023F PE or +1.5SD to its long-term mean.

Risks

Longer-than-expected COVID-19 outbreak.




Figure 1: SPA's 3Q22 earnings review



Figure 2: SSSG





Figure 4: International tourist arrivals forecasts




